**Standing Updates:**

**TOPIC:** Budget & Financial Update

**DISCUSSION:**

- Karen Amos, Chief Financial Officer, presented highlights of the FY19 financial statements through October 31, 2018. Karen reviewed budget vs actual expenditures noting PBSA is currently tracking closely with budget.
- Greg Giornelli, Chief Executive Officer, discussed APS Per Pupil Revenue adjustment beginning in December resulting from the October enrollment count. PBSA has met with other Charter/Partnership Schools and collectively have entered into conversations with APS around improving enrollment projections.

**TOPIC:** Instructional Update

**DISCUSSION:**

- Barbara Preuss, Head of Schools, presented an update on CCRPI scores now described as rankings. Barbara discussed how the rankings for all of our schools compared to other APS schools and the State of Georgia. Although Thomasville Elementary & Carver STEAM Academy are still labeled “Priority Schools”, Slater Elementary & Price Middle School are no longer on the list.
- Greg announced we have entered into an agreement with Northstar, an educational consulting firm to lead work around formalizing our instructional framework. Northstar deliverables will include documenting how we approach instruction at our schools.

- Greg introduced Andrea Arroyo, the new Director of Community Engagement. Greg presented the results of the Community Engagement Step Back which reviewed the work conducted in the first year of the program.
